



World Travel, Inc. Leisure Customer Referral Program

Effective Date: September 10, 2018

Program End Date: December 31, 2018

Program Overview:

World Travel, Inc.'s Leisure Office Referral Program ("Referral Program") is offered by World Travel, Inc. and provides an opportunity for World Travel, Inc. customers to earn a \$25.00 World Travel, Inc. gift card to apply towards their next vacation booked by World Travel, Inc.

Program Details:

World Travel, Inc. will gift a \$25.00 World Travel, Inc. gift card (the "Gift Card") to any Eligible Referrer (defined below) who refers an Eligible New Customer (defined below) in compliance with the Referral Program terms and conditions, set forth herein. The Gift Card will be activated after the Eligible New Customer travels on the Eligible Hotel/Tour/Cruise Package (defined below) with a World Travel, Inc. Leisure Agent (defined below).

Definitions:

"Eligible Hotel/Tour Package" means a hotel stay for any commissioned hotel stay with a total cost that is no less than \$2,500.00 that is booked by World Travel, Inc. Leisure Agent, or a tour or cruise package that includes commissioned airfare and hotel with a total cost that is no less than \$2,500.00 for reservations that are made by a World Travel, Inc. Leisure agent.

"Eligible Referrer" means a person who refers an Eligible New Customer to World Travel, Inc.'s Leisure Office. In addition, an Eligible Referrer must be: (1) a legal resident of the U.S., District of Columbia, Puerto Rico, or the U.S. Virgin Islands; and (2) at least 18 years of age or older; and (3) an existing World Travel, Inc. traveler who has an active leisure or corporate travel profile managed by World Travel, Inc.

"Eligible New Customer" means a person (1) who has not completed a Leisure Booking with World Travel, Inc. in the twelve months prior to the Effective Date of the Referral Program and (2) who books an Eligible Hotel/Tour/Cruise Package with World Travel, Inc.'s Leisure Office.

"Gift Card" means a gift card with a denomination of \$25.00 that is issued by World Travel, Inc. and redeemable only by World Travel, Inc. for Leisure Bookings.

"World Travel, Inc. Leisure Agent" means a travel agent who works at World Travel, Inc.'s Leisure Office.

"Leisure Booking" means any of the following, tour or cruise package booked by a World Travel, Inc. Leisure Agent.

"Leisure Office" means World Travel, Inc.'s vacation/retail office located at 1050 E. Philadelphia Avenue, Gilbertsville, PA 19518.

Referral Program Exclusions:

Reservations made for corporate bookings are excluded from the Referral Program.
