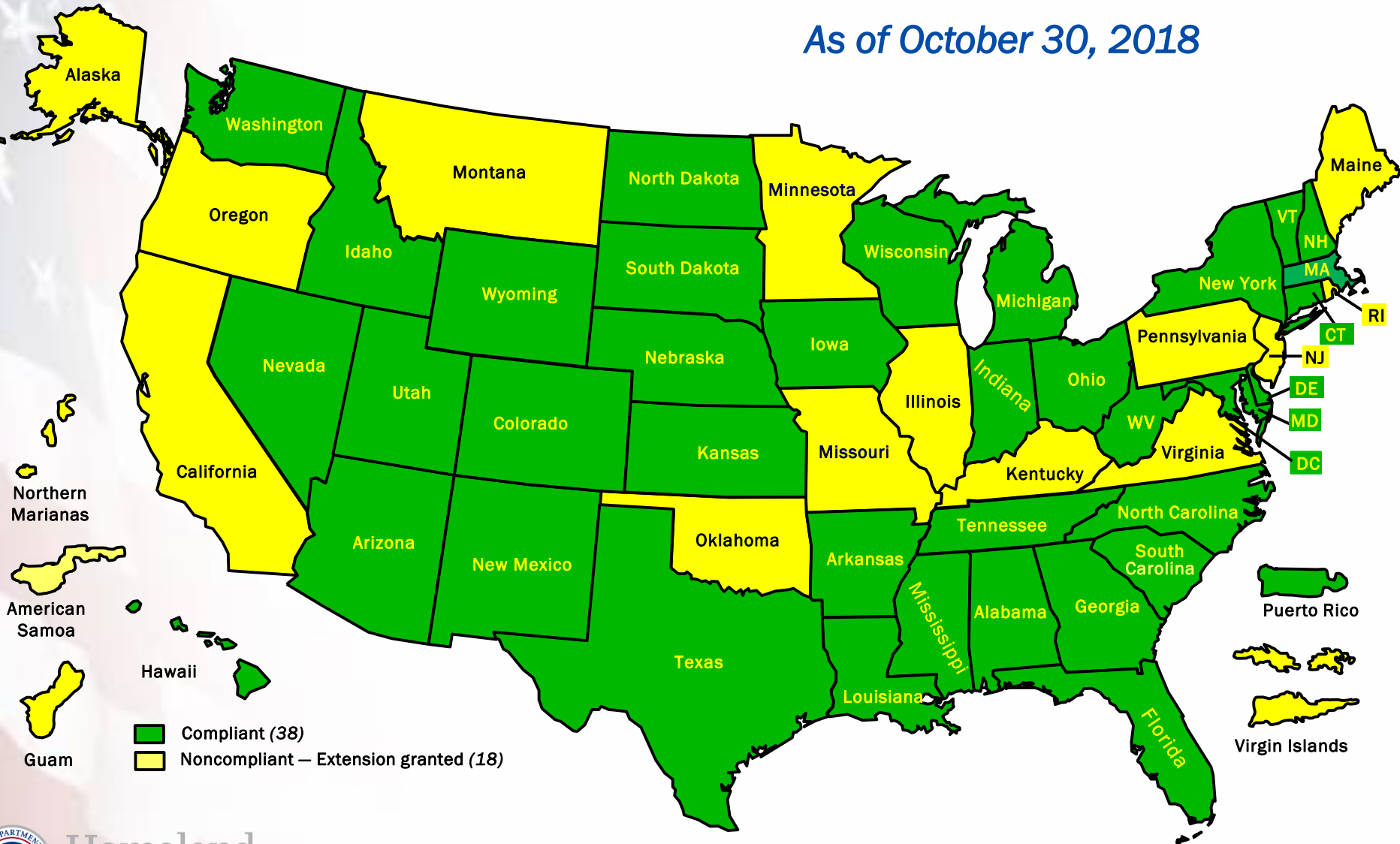

# REAL ID Act Overview

- ❑ Establishes minimum standards for the secure issuance of state-issued driver's licenses and identification cards.
- ❑ Prohibits Federal agencies from accepting for official purposes driver's licenses and identification cards from non-compliant states. These purposes are:
  - Accessing Federal facilities
  - Boarding federally regulated commercial aircraft
  - Entering nuclear power plants
- ❑ Covers 56 jurisdictions: 50 states, DC and 5 territories.
- ❑ Authorizes DHS to:
  - Issue regulations and set standards
  - Make grants to states
  - Grant limited compliance extensions of time
  - Make Compliance Determinations
  - Recertify states every 3 years
  - Enforce requirements at federal facilities

# REAL ID Phased Enforcement

1	Restricted areas for DHS HQ	04/21/2014
2	Restricted areas for Federal facilities & nuclear power plants	07/21/2014
3	<b>Semi-restricted areas for Federal facilities</b> <i>(i.e., Facilities where public can access but must present ID)</i>	
3a	<i>Federal Security Levels 1 and 2</i>	01/19/2015
3b	<i>Federal Security Levels 3,4, and 5; military facilities</i>	10/10/2015
4	<b>Boarding Commercial Aircraft</b>	
4a	<i>Passengers from noncompliant states without extensions ("state-based")</i>	1/22/2018
4b	<i>Passengers from all states without compliant documents ("card-based")</i>	<b>10/1/2020</b>
